

RESOLUTION AND PROCLAMATION OF REGULAR SCHOOL ELECTION

WHEREAS, the Board of Education of Ruidoso Municipal School District No. 3 (herein the "Board") as the governing board of Ruidoso Municipal School District No. 3, in the County of Lincoln and State of New Mexico (the "District"), has determined upon its own initiative that a regular election shall be held on February 3, 2015, (the "Election") pursuant to Sections 1-22-1 through 1-22-19, NMSA 1978; and that a Proclamation of Election shall be issued in accordance with Section 1-22-4, NMSA 1978;

WHEREAS, the board has determined that three positions on the Board are to be filled at such Election by submitting to the qualified electors of the District, the names of candidates qualified to appear on the ballot;

WHEREAS, the persons who desire to fill such positions on the Board shall be required to file declarations of candidacy or declarations of intent to be a write in candidate, all in accordance with Section 1-22-1 *et. seq.*, NMSA 1978; and

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF EDUCATION OF RUIDOSO MUNICIPAL SCHOOL DISTRICT NO. 3, CONSTITUTING THE GOVERNING BOARD OF RUIDOSO MUNICIPAL SCHOOL DISTRICT NO. 3, IN THE COUNTY OF LINCOLN AND STATE OF NEW MEXICO THAT THE FOLLOWING PROCLAMATION BE AND IT HEREBY IS ISSUED:

PROCLAMATION OF ELECTION

Section 1. On the 3rd day of February, 2015, there will be held in the Ruidoso Municipal School District No. 3, in the County of Lincoln and State of New Mexico (the "District"), a regular school district election (the "Election") for the purpose of submitting to all qualified electors of the District the names of candidates for three positions on the Board of Education of the District (the "Board").

Section 2. The County Clerk of Lincoln County is the proper filing officer and the county clerk of record and shall conduct this Election in accordance with the School Election Law, being Sections 1-22-1 through 1-22-19, NMSA 1978, the Election Code and the Federal Voting Rights Act, as amended.

Section 3. The polls shall be open between the hours of 7:00 a.m. and 7:00 pm. on the Election day.

Section 4. The following positions on the Board shall be filled by a vote of the qualified voters:

Position 1, a four year term commencing March 1, 2015.

Position 2, a four year term commencing March 1, 2015, and

Position 3, a four year term commencing March 1, 2015.

Section 5. Declarations of candidacy and a sworn statement of intent are to be filed with the County Clerk of Lincoln County, in Carrizozo, New Mexico, between the hours of 9:00 a.m. and 5:00 p.m. on December 16, 2014, being the third Tuesday in December. Candidates must be residents of the District as of the date of this proclamation.

Section 6. A declaration of intent to be a write-in candidate is to be filed with the County Clerk of Lincoln County, in Carrizozo, New Mexico, before 5:00 p.m. on December 30, 2014.

Section 7. All Lincoln general election precincts wholly or partially within the District shall be consolidated for this Election. Qualified voters of the District shall vote at the polling place located below (except for the absent voters precinct):

CONSOLIDATED PRECINCT ONE (Consisting of Lincoln County general election precincts 8, 9, 10, 11, 18, and 22 plus those parts of precincts 4, 5, 6, 7, 12, 14, and 21 that are within the boundaries of the Ruidoso Municipal School District No. 3)

POLLING PLACE: Ruidoso Convention Center

ABSENT VOTERS PRECINCT (For voters who are absentee for any precinct within Ruidoso Municipal School District No. 3)


Section 8. Absentee voting will be permitted as authorized by Section 1-22-19, NMSA 1978, and the Absent Voter Act of the Election Code, i.e., Sections 1-6-1 through 1-6-25, NMSA 1978. Applications for absentee ballots may be obtained from the office of the County Clerk of Lincoln County, Lincoln County Courthouse, Box 338, Carrizozo, NM 88301. Absentee ballots of District voters may be marked in person at the office of the County Clerk of Lincoln County, Lincoln County Courthouse, Carrizozo, New Mexico, commencing at 8:00 a.m. Friday, January 9, 2015, being the twenty-fifth day preceding the Election, and until 5:00 p.m. January 30, 2015, being the Friday immediately prior to the Election. On the day of Election, the County Clerk of Lincoln

Section 11. The foregoing Proclamation of Election shall be filed with the County Clerk of Lincoln County on November 25, 2014, being the last Tuesday in November.

Section 12. The Proclamation of Election shall then be published once in the *Ruidoso News*, a newspaper of general circulation in the District, in English and Spanish, on or before the 15th of December 2014, being the fiftieth day preceding the Election.

Section 14. The Superintendent of Schools and the officers of the District are authorized and directed to take all action necessary as appropriate to implement the provisions of this resolution.


