An 'Approval To Construct' approval shall lapse and become invalid SIX months from the date of approval unless:

- A substantial portion of the work described in the plans and specifications has commenced by such anniversary date, or
- An application for a one-time renewal is submitted within 180 days of expiration.

An 'Approval To Construct' approval becomes void if an extension of time is not granted by the Planning Department if:

- Construction does not begin within six months after the date the 'Approval To Construct' approval was issued.
- There is a halt in construction of more than one year.
- Construction is not completed within one year after the date the 'Approval To Construct' approval was issued.

This project has met the Lincoln County requirements, and an "approval to construct" is issued.
