**ORDER ON PETITION TO CONSOLIDATE THE DESIGNATED
POLLING PLACES FOR THE PRECINCTS IN THE COUNTY OF LINCOLN
FOR THE PURPOSES OF THE VOTING PROCESS IN THE
2020 PRIMARY ELECTION AND PRIMARY PRESIDENTIAL ELECTION ONLY**

THIS MATTER, having come before the Court on the Petition of the Lincoln County Clerk, pursuant to Resolution 2019-40 adopted on April 21, 2020, by the Board of County Commissioners of Lincoln County, New Mexico, and pursuant to NMSA 1978, §1-3-4 (1969 Comp.), for an Order consolidating the designated polling places/voter convenience centers of the precincts in the County of Lincoln for the purposes of the voting process in the 2020 Primary Election and Primary Presidential Election only; and the Court having been fully advised in the premises, FINDS:

1. That it is in the best interests of the voters of the County of Lincoln to consolidate the designated polling places/voter convenience centers of the precincts in the County of Lincoln for the purposes of voting in the 2020 Primary Election and Primary Presidential Election only.

2. That it is in the best interests of the voters of the County of Lincoln to remove certain designated polling places/voter convenience centers of the precincts in the County of

Lincoln for the purposes of voting in the 2020 Primary Election and Primary Presidential Election only.

3. That it is in the best interests of the voters of the County of Lincoln that any voter of the County should be allowed to vote on a regular ballot at any polling place/voter convenience center in the County of Lincoln.

IT IS, THEREFORE, ORDERED, ADJUDGED, and DECREED that:


1. The designated polling places/voter convenience centers for the precincts in the County of Lincoln for the 2020 Primary Election and Primary Presidential Election only are as follows:

1, 2, 3, 4, 13, 14, 17, 19, 20	Lincoln County Courthouse 300 Central Avenue Carrizozo, New Mexico
5, 6, 7, 8, 9, 21	Ruidoso Convention Center 111 Sierra Blanca Drive Ruidoso, New Mexico
10, 11, 12, 15, 16, 18, 22	Ruidoso Downs Zia Center 26337 US Highway 70 Ruidoso Downs, New Mexico

2. The following polling places/voter convenience centers for the precincts in the County of Lincoln are hereby removed for the purposes of the 2020 Primary Election and Primary Presidential Election only:

- A. Capitan Municipal Schools, 150 Forrest St., Capitan, NM
- B. Corona Village Hall, 461 Main St., Corona, NM
- C. Hondo Valley Public Schools, 111 Don Pablo Ln., Hondo, NM

3. Any voter of the County shall be allowed to vote on a regular ballot at any of the designated polling places/voter convenience centers in the County of Lincoln.
