

PRIMARY ELECTION PROCLAMATION

Pursuant to the Primary Election Law, NMSA 1978, Sections 1-11-1 to -19 (1969, as amended through 2019), and the Presidential Primary Act, NMSA 1978, Sections 1-15A-1 to -11 (1977, as amended through 2011), I, Whitney Whittaker, Lincoln County Clerk, by virtue of the authority vested in me, do hereby issue the following proclamation:

That a Primary Election is called to be held throughout the State of New Mexico and in each county and precinct thereof on June 2, 2020;

That a Primary Election shall be applicable to the following political parties: the Democratic Party, the Republican Party, and the Libertarian Party; and

That the Primary Election shall be for the purpose of permitting the Democratic Party, the Republican Party, and the Libertarian Party to nominate candidates for the following offices:
